INTRODUCTION

This document is intended to inform the differences and similarities between an FBO and a PMA. In this context, an FBO is a Faith Based Organisation (508c1a), also known as a church, ministry, order or society, and a PMA is a Private Membership Association, also known as an auxiliary organization of The Universe Spiritual Ministry, which is an existing FBO.

Whether setting up an independent FBO, or choosing to operate under the umbrella of an existing FBO such as The Universe Ministry, you will unlock the keys to a Sovereign Kingdom with [Religious Freedoms](#).



DIFFERENCES AND SIMILARITIES



TIME

Setting up an FBO can be as quick as 2-4 weeks, but generally takes 6-12 months

Setting up a PMA can be as quick as 1-3 days, but generally takes 1-2 weeks

PRICE

Setting up an FBO starts from \$5,000

Setting up a PMA starts from \$500/year

REQUIREMENTS OF AN FBO



Certain characteristics are generally attributed to churches. These attributes of a church have been developed by the IRS and by court decisions. They include:

1. Distinct legal existence
2. Recognized creed and form of worship
3. Definite and distinct ecclesiastical government
4. Formal code of doctrine and discipline
5. Distinct religious history
6. Membership not associated with any other church or denomination
7. Organization of ordained ministers
8. Ordained ministers selected after completing prescribed courses of study
9. Literature of its own
10. Established places of worship
11. Regular congregations
12. Regular religious services
13. Schools for the religious instruction of the young / Schools for the preparation of its members and ministers.

While the above attributes are not mandatory requirements for establishing a 508c1a, it may be beneficial to demonstrate that your Faith Based Organisation is conducting itself in accordance with these attributes if the IRS or a governmental body seeks to challenge the validity of your FBO in court.

A US citizen is required; as a voting or non-voting board member. It is possible to hire TAO Fallenstar as a non-voting board member in the event that you do not have a US citizen in your founding team.

REQUIREMENTS OF A PMA



The Universe Ministry satisfies the requirements of an FBO so that you don't have to. A PMA with The Universe Ministry is protected under the umbrella of its existing FBO so you can focus on building your new paradigm organization, not a new religion! The requirements to setting up a PMA with The Universe Ministry are:

- Act in the interest of the collective
- Agree to the [50 Universal Laws](#)
- Swear an [Oath to The Universe](#)
- Fair compensation to all stakeholders
- An aligned mission - A clear mission statement that serves one or more of The Universe ministry intentions;

 - Sovereignty

 - Regeneration
 - Conscious Health Care
 - New paradigm Education
 - Food Abundance
 - Free Energy
 - Universal Basic Income

 - Vaccination Rights
 - Freedom of Speech
 - 17 SDG's.
 - Universal Passport

*A US citizen is not required (The Universe Ministry has a US citizen on its board).

AGREEMENTS

FBO

Agreements of FBO (508c1a) / Spiritual Foundation

We request that you use the tools and information that we provide to serve the divine potential of the world in some way and to operate with honesty and integrity. We request that you do not offer these legal documents, in whole or part, to others, as a service or product for sale or exchange to anyone. They are proprietary documents and we don't want people attempting to copy them and try to operate a 508 church without training or support.

PMA

Giving back - The PMA must give at least 51% of surplus income to a community or cause: 20% to the Universe Ministry and at least 31% to another PMA, charity, community or cause.

Donate - The PMA will donate 1-10%* of its annual revenue to The Universe.

*We recommend that you add 1-10% to the price of any products or services that your PMA offers and publicize that 1-10% of your revenue is donated to The Universe Ministry for spiritual, humanitarian, environmental and philanthropic activity.

Participation – At least one of the PMA board members will attend the monthly, quarterly and yearly meetings of The Universe.

Attendance of less than 75% of these meetings 3 years in a row could result in this Private Membership Association being deactivated by The Universe.



RIGHTS

A PMA includes the same founding declaration as an FBO including rights such as;

- 1.Acquiring and possessing, by donation, gift, bequest, devise, and purchase, and holding and maintaining, property—real, personal, and mixed—holding title absolute by conveyance, with right for granting, selling, conveying, renting, and otherwise disposing of said property as may be necessary for furthering the objectives of the Ministry, for the use and behalf of the PMA forever, in an unalloyed temporal and spiritual capacity.
- 2.Exercising seigniorage; borrowing and lending money; giving promissory notes as well as other written obligation therefore by note, and securing the payment thereof by a lien, such as mortgage, upon hereditaments, both corporeal and incorporeal, real, personal, and mixed.
- 3.Buying, selling, leasing, mortgaging, and in every way dealing in land and chattels in the same manner that a natural man may, and without the order of any court.
- 4.Receiving bequests and devises for exclusive use of the Self-Supported Ministry in the same manner as a living, sentient man.
- 5.Appointing, and being appointed as, an attorney in fact.
- 6.Contracting and being contracted with in the same manner as a natural man, in proper capacity and full standing.
- 7.Suing and being sued, pleading and being pleaded, in courts of competent jurisdiction.
- 8.Having and using a common seal by which all deeds and acts of the Ministry may be authenticated.
- 9.Opening, and possessing sole and exclusive signing authority on, non-interest-bearing bank accounts of any kind whatsoever.

Exercising any other just, lawful, and ethical rights and powers as may be declared by authority of the Self-Supported Spiritual Church Ministry, as established at any time in accordance with the Tenets, Creeds, and Principles of the PMA, under authority of the sovereign and unalloyed right inhering in the eternal Covenant of the Undersigned with the Undersigned's Creator.
